### **PLEASE SIGN AND RETURN ONE COPY**

The Rules and Regulations listed below are deemed necessary for the proper maintenance of the Sports Camp Program of the SYJCC. Teenagers will **NOT** be permitted to participate in SYJCC's Sports Camp program unless this contract is agreed to and signed by the Sports Camper and a parent/guardian.

1. The SYJCC agrees to furnish the Sports Camper with a social, recreational, meaningful and safe program.
2. The Sports Camper agrees to abide with all rules and SYJCC policies as set down herein and as explained at the various meetings of Sports Camp. The Sports Camper also agrees to participate in the program so as to derive the full benefit of the program.
3. The items outlined in the following list are strictly prohibited:
  - a) Alcoholic beverages, including non-alcoholic beer, drugs, cigarettes, or marijuana **MUST NOT** be brought, possessed, bought, shared or used by campers.
  - b) Gambling of any kind.
  - c) Excessive public display of affection, or other blatant disrespect for the surrounding society.
  - d) Disturbing the peace, undue boisterousness, rowdiness, disturbing the atmosphere of a neighborhood or SYJCC function.
  - e) No verbal, physical or visual harassment of another person.
  - f) No actual or threatened violence toward any individual or group.
  - g) Failing to cooperate with an adult supervisor or leader.

Sports Campers who are found to disobey rules and SYJCC policy as to drugs, alcohol, shop lifting, vandalism or other criminal acts may be prosecuted under the law without the protection of the SYJCC, and terminated from camp. **NO** refund will be made.

4. As in all the SYJCC camps, Sports Camp provides "line-of-sight" supervision. Campers will be in small groups with an assigned staff member at all times. Sports Campers are never to leave their group or to be without the supervision of a staff member.

5. Campers who disobey SYJCC policy relating to curfew regulations, appropriate behavior, etc., may be separated from their group and may have their trip bus changed. Campers who continue to disobey SYJCC policy as stated above will be suspended from camp for a length of time to be determined at a conference which will include Camper and Parent/Guardian. The SYJCC reserves the right to remove or suspend a child from camp - in such cases - **NO REFUND WILL BE MADE.**

6. Parents/Guardians will be required to pay for any damages caused by the Sports Camper.
7. The Sports Camper is responsible for his/her personal property. **THE SYJCC ASSUMES NO RESPONSIBILITY FOR DAMAGED, LOST OR STOLEN CAMPER PERSONAL PROPERTY.**
8. In the event of an emergency disciplinary situation, parents/guardians will be required to pick up the Sports Camper regardless of where he/she is, or the Sports Camper will be sent home at the parent's/guardian's expense. It may be necessary to send the Sports Camper home unsupervised.
9. In the event of a health emergency, the Sports Camper will be treated by a doctor/hospital in the immediate area. Medical insurance coverage is \$100.00 deductible.
10. An up-to-date, completely filled out and notarized Medical Form and release **MUST** be on file prior to beginning of camp session. Sports Camper **CANNOT** attend Program without a proper medical.
11. Medication (prescription or non-prescription) must be given to the camp in the original container with a doctor's note and be administered by the camp.
12. The SYJCC staff reserves the right to inspect all belongings.
13. There will be **NO** monies refunded, or time made up, for loss of days due to sickness, injury or any other reason.
14. It is understood that all trip itineraries are tentative and can be changed at any time.
15. We will make every effort to honor a Sports Camper's request to be with his/her friends.
16. It may become necessary to adjust buses and/or groups of campers due to enrollment changes. Again, the SYJCC reserves the right to do this and cannot guarantee that group requests will be granted.
