### Kidsplace Terms & Conditions

- The last month's tuition is required upon registration, and will be applied to your last month's payment.
- Tuition is due on the first of the month preceding the month of service. If paid after the 10th of the month, a \$25 late fee will be assessed.
- A sibling discount of 10% off each sibling after the first registrant will be deducted from your monthly tuition. Discount is off the less-expensive sale in any child care program, including Early Childhood.
- Late pickup fees will be assessed at \$15 per each 15-minute increment after 6:00 pm closing. The fee will be charged to credit card you have on file.
- There are no refunds, make-up days or reduction in tuition for holidays, sick days, family vacations or extracurricular activities.
- No refunds will be granted for short-term school closures for occurrences including (but not limited to) a pandemic, government-imposed shutdown, communicable diseases, safety, acts of God, weather-related emergencies, unknown circumstances beyond our control, or for any other reason (resting within the sole discretion of the Suffolk YJCC administration) deemed related to the health, safety and/or wellbeing of our members (inclusive of family and children).
- Please call the SYJCC at (631) 462-9800 or email the Director before 1:00 pm if your child will not be attending Kidsplace on their scheduled day.
- Extra days must be paid for at time of request and will be granted only if space is available and approved by the Director or their designee.
- Switching of days, if space is available, is allowed with approval from the Director or their designee. Switching of days during public school recess weeks is not permitted.
- All schedule changes must be submitted in writing.
- In the event that a parent, emergency contact or family physician cannot be contacted in an emergency, SYJCC staff have my permission to transport my child to a hospital emergency room for treatment.
- A Medical form, completed by your child's physician, must be on file prior to your child starting at the SYJCC.
- I hereby grant permission to reproduce and publish any photograph, video or likeness of my child for advertising, social media, publications, or any lawful purpose.
- I hereby give permission for my child to participate in all Center activities and programs as planned and supervised by the SYJCC Kidsplace staff.
- I understand that in addition to being in his or her room, my child will be moving throughout the hallways of the SYJCC and will be in rooms throughout the building under SYJCC Kidsplace staff supervision.
- Participants assume all risks associated with the use of all facilities. The Suffolk YJCC and all associated parties are not liable for any injury or harm that occurs on the premises.
